ABOUT NEW CHOICES WAIVER

The New Choices Waiver Program is designed to serve individuals who are residing long term in a nursing facility, licensed assisted living facility, licensed small health care (Type N) facility or another type of Utah licensed medical institution (except institutions for mental disease). The Program offers an option for these individuals to move into integrated community-based settings if they wish to do so and if their needs can be safely met in the setting that they have chosen. When an individual is enrolled in the New Choices Waiver Program, they may receive an expanded package of supportive services through Medicaid which are intended to help with community-based living and are based on the assessed need of the individual.

HOW TO APPLY

Applications may be accessed at https://medicaid.utah.gov/ltc-2/nc/ or by calling the New Choices Waiver Program Office at 801-538-6155, option 6.

To qualify, an applicant must:



- Be 18 years or older
- Meet Utah Medicaid financial requirements
- Require a nursing facility level of care
- Have a primary condition not due to mental illness
- Not need intensive skilled care
- Not be eligible for an ICF/ID facility

The applicant must also meet one of the following:

- Be in a Medicaid-funded nursing facility for 90+ days
- Be in a Medicare-funded medical institution for 30+ days, with plans to transfer to a Medicaid-certified nursing facility for 60+ days
- Be in a licensed assisted living or small health care facility for 365+ days
